GENERAL CONDITIONS

With this entry, participants acknowledge acceptance of the general conditions, and agree to conform to any instructions given by the stewards.

Ollon-Villars hillclimb is a demonstration for your pleasure and that of the public. The aim is to recreate the atmosphere of Ollon-Villars as it was during the historic meetings of 1953-1971. In its present form, it is by no means a race, but a presentation of exceptional historic competition vehicles. The heats are not being run against the clock. The topography and the difficulty of the course enable the vehicles to run in conditions that are attractive for everyone.

The demonstration takes place under the conditions of the Swiss Highway Code even though the road will be closed during heats. Particular attention should be paid to the crossing of Huémoz (40 kph), Chesières (50 kph) and between Arrival and Paddock in Villars (30 kph).

Any person who does not have the physical and mental capabilities to drive a vehicle because he/she is under the influence of alcohol, drugs, medicine or for any other reason is deemed unfit for driving during this period and must abstain from doing so.

The entrant holds a current driving license for the category of vehicle entered and driven during Ollon-Villars. Only vehicles recognised as conform by the scrutineers will be allowed to participate. A change of driver after the administrative

checks is not allowed. Drivers take part only with the vehicle they entered and presented for scrutineering.

All participants take part at their own risk. The organisers accept no responsibility towards entrants, drivers, helpers and other third parties, for injury or damage caused to people or property. All entrants/drivers are solely responsible for their insurance. Entrants take part entirely at their own risk. Regarding theft of vehicles or equipment, the organiser can in no way be held accountable in the case of disappearance of participants' property.

Through their participation, drivers renounce all claims, civil or criminal, against the organiser, his staff, assistants or voluntary helpers.

The organiser cannot guarantee that all drivers will be able to run; they reserve the right to cancel all or part of the heats for reasons of safety, weather or events over which they have no control. No damages will be paid by the organiser.
